* APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, Rogue River National Forest (Name of applicant) of Medford (Post office), County of Jackson, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Spring at head of Imaha Creek (Name of stream), a tributary of Rogue River

2. The amount of water which the applicant intends to apply to beneficial use is Less than one (1) cubic feet per second. (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is Domestic supplies (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 1000 ft. S and 300 ft. E from the N 1/4 corner of Sec. 15, T. 33 S., R. 4 E. W.M. (Section or subdivision)

being within the SW 1/4 SW 1/4 NW 1/4 NE 1/4 of Sec. 15, Tp. 33 S., R. 4 E., W. M., in the county of Jackson (Give smallest legal subdivision) (N. or S.) (E. or W.)

5. The Pipe line (Main ditch, canal or pipe line) to be 500 feet (Miles or feet) in length, terminating in the SW 1/4 NE 1/4 of Sec. 15, Tp. 33 S., R. 4 E., W. M., the proposed location being shown throughout on the accompanying map. (Smallest legal subdivision) (N. or S.) (E. or W.)

DESCRIPTION OF WORKS

DIVERSION WORKS—

Concrete box 5'X5' at spring. Pipe running from box.

6. (a) Height of dam feet, length on top feet, length at bottom feet; material to be used and character of construction.

(Loose rock, concrete, masonry, rock and brush, timber crib, etc., wasteway over or around dam)

(b) Description of headgate (Timber, concrete, etc., number and size of openings)

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.11 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from

Spring at Head of Immaha Creek

The use to which this water is to be applied is Domestic and Ram, being 0.01 c.f.s. for domestic and 0.10 c.f.s. for ram.

If for irrigation, this appropriation shall be limited to of one cubic foot per second

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is June 14, 1939

Actual construction work shall begin on or before August 15, 1940 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1941

Complete application of the water to the proposed use shall be made on or before October 1, 1942
