

* APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, John McCadden (Name of applicant) of Agness, Oregon (Post office), County of Curry, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

1. The source of the proposed appropriation is small unnamed creek in Sec. 29, T. 35 S., R. 11 W., W.M. (Name of stream) Illinois River, a tributary of

2. The amount of water which the applicant intends to apply to beneficial use is .50 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is Domestic and irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located ft. and ft. from the corner of approximately S. 60° W. 57.5 chains from section corner common to secs. 20, 21, 28 & 29., T. 35 S., R. 11 W., W.M. (If preferable, give distance and bearing to section corner)

being within the SE 1/4 of the NW 1/4 of Sec. 29, Tp. 35 S, R. 11 W, W. M., in the county of Curry (Give smallest legal subdivision) (N. or S.)

5. The pipe line to be 950' in length, terminating in the SW 1/4 of the NW 1/4 of Sec. 29, Tp. 35 S., R. 11 W, W. M., the proposed location being shown throughout on the accompanying map. (Main ditch, canal or pipe line) (Miles or feet) (Smallest legal subdivision) (N. or S.)

DESCRIPTION OF WORKS

DIVERSION WORKS—

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.07 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Small Unnamed Creek in Section 29, T. 35 S., R. 11 W.

The use to which this water is to be applied is Irrigation and Domestic, being 0.06 c.f.s. for irrigation and 0.01 c.f.s. for domestic.

If for irrigation, this appropriation shall be limited to 1/50th of one cubic foot per second or its equivalent for each acre irrigated throughout the irrigation season from April 1st to November 1st of each year,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is July 31, 1939

Actual construction work shall begin on or before October 20, 1940 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1941

Complete application of the water to the proposed use shall be made on or before October 1, 1942
