

APPLICATION FOR A PERMIT TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF OREGON

I, Minnie Smiley (Name of Applicant.)

State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

2. The amount of water which the applicant intends to apply to beneficial use is 1/4 cubic feet per second.

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: The appropriation for irrigation purposes shall be limited to one-eightieth of one cu. ft. per sec. for each acre irrigated. The use hereunder shall conform to any reasonable rotation system ordered by the proper State officers. The priority date of this permit is December 26, 1912

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 3/80 cubic feet per second. or its equivalent in case of rotation

Actual construction work shall begin on or before February 19, 1914 and shall thereafter be prosecuted with reasonable diligence and be completed on or before February 19, 1915

Complete application of the water to the proposed use shall be made on or before October 1, 1915
