To Appropriate the Public Waters of the State of Oregon

I, Jessie I. Bennett (Name of applicant) of Dallas (Post office), County of Polk, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation.

1. The source of the proposed appropriation is Unnamed Stream (Name of stream), a tributary of Salt Creek.

2. The amount of water which the applicant intends to apply to beneficial use is 0.09 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is Domestic & Stock (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 297 ft. South and 1518 ft. West from the NE corner of Section 11, T. 7 S., R. 6 W., (Section or subdivision) (If preferable, give distance and bearing to section corner)

This is to certify that I have examined the foregoing application and do hereby grant the same,
SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use
and shall not exceed 0.09 cubic feet per second measured at the point of diversion from the
stream, or its equivalent in case of rotation with other water users, from

Unnamed Stream

The use to which this water is to be applied is Domestic and Stock, being 0.08 c.f.s. for
domestic and 0.01 c.f.s. for stock

If for irrigation, this appropriation shall be limited to _____ of one cubic foot per
second

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is August 19, 1940

Actual construction work shall begin on or before October 21, 1941 and shall
thereafter be prosecuted with reasonable diligence and be completed on or before
October 1, 1942

October 1, 1943
