CERTIFICATE NO. 14318

To appropriate the Public Waters of the State of Oregon

I, Elmer R. Nelson (Name of applicant)

of Portland, County of Multnomah, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Nelson Spring (Name of stream), a tributary of Pacific Ocean

2. The amount of water which the applicant intends to apply to beneficial use is 5 gallons per minute. (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is Domestic (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 491.4 ft. North and 141.4 ft. West from the 1/4 Sec. corner of Sections 17 and 20. (Section or subdivision) (If preferable, give distance and bearing to section corner)

(If there is more than one point of diversion, each must be described. Use separate sheet if necessary) being within the SE 1/4 of SW 1/4 of Sec. 17, Tp. 1 N., R. 10 W., W. M., in the county of Tillamook.

5. The pipe line to be 550 feet in length, terminating in the Lot 3 of Sec. 20, Tp. 1 N., R. 10 W., W. M., the proposed location being shown throughout on the accompanying map.

DESCRIPTION OF WORKS

DIVERSION WORKS—

6. (a) Height of dam 3 feet, length on top 3 feet, length at bottom 3 feet; material to be used and character of construction wood box (Loose rock, concrete, masonry, rock and brush, timber crib, etc., wasteway over or around dam)

(b) Description of headgate no headgate (Timber, concrete, etc., number and size of openings)

(c) If water is to be pumped give general description gravity (Size and type of pump)

(Size and type of engine or motor to be used, total head water is to be lifted, etc.)

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.01 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Nelson Spring

The use to which this water is to be applied is Domestic

If for irrigation, this appropriation shall be limited to of one cubic foot per second

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is August 14, 1940

Actual construction work shall begin on or before January 10, 1942 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1943

Complete application of the water to the proposed use shall be made on or before October 1, 1944
