

\* APPLICATION FOR A PERMIT

CERTIFICATE NO. 14323

To Appropriate the Public Waters of the State of Oregon

I, L. J. McLaughlin (Name of applicant) of Lowell (Post office), County of Lane, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation.

1. The source of the proposed appropriation is Stream - Has no name (Name of stream), a tributary of middle fork of Willamette

2. The amount of water which the applicant intends to apply to beneficial use is 0.02 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

\*\*3. The use to which the water is to be applied is Domestic, including irrigation of garden & lawn, not exceeding 1/2 acre. (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 1620 ft North and 2330 ft West from the SE corner of Section 19. (N. or S.) (E. or W.) (Section or subdivision) (If preferable, give distance and bearing to section corner)

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.01 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from

Unnamed Stream

The use to which this water is to be applied is Domestic, including the irrigation of garden and lawn not exceeding 1/2 acre in area.

If for irrigation, this appropriation shall be limited to of one cubic foot per second

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is October 11, 1940

Actual construction work shall begin on or before January 10, 1942 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1943

Complete application of the water to the proposed use shall be made on or before October 1, 1944
