

* APPLICATION FOR A PERMIT

To Appropriate the Public Waters of the State of Oregon

I, C. E. Watts (Name of applicant) of Coquille (Post office), County of Coos, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is From Two, not named, Streams (Name of stream) which are tributary of North fork of Coquille River

2. The amount of water which the applicant intends to apply to beneficial use is 0.01 cubic feet per second. 0.005 cu. ft. per sec. from each of two (all available) (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is domestic supply (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 510 North 600 West S. E. 50 ft. North and 720 ft. West from the S. E. corner of NE 1/4 of SE 1/4 of Section 7, T. 27 S., R. 11 W., W. M., (Section or subdivision) (If preferable, give distance and bearing to section corner)

(If there is more than one point of diversion, each must be described. Use separate sheet if necessary) being within the NE 1/4 of SE 1/4 of Sec. 7, Tp. 27 South, R. 11 West, W. M., in the county of Coos.

5. The Pipe Lines to be 400 feet 500 feet (Main ditch, canal or pipe line) (Miles or feet) in length, terminating in the NE 1/4 of SE 1/4 of Sec. 7, Tp. 27 South, R. 11 West, W. M., the proposed location being shown throughout on the accompanying map.

DESCRIPTION OF WORKS

Diversion Works—

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.01 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from two unnamed streams, being 0.005 c.f.s. from each stream.

The use to which this water is to be applied is Domestic

If for irrigation, this appropriation shall be limited to of one cubic foot per second

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is July 11, 1941

Actual construction work shall begin on or before September 15, 1942 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1943

Complete application of the water to the proposed use shall be made on or before October 1, 1944
