

* APPLICATION FOR A PERMIT

To Appropriate the Public Waters of the State of Oregon

I, Lester C. Davidson (Name of applicant) of Route 6, Box 107, Salem, (Post office) County of Marion State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Three Springs, tributary to Unnamed Creek (Name of stream), a tributary of Little Pudding River

2. The amount of water which the applicant intends to apply to beneficial use is 0.40 cubic feet per second, being .10 c.f.s. from #2, .10 c.f.s. from #3, and .20 c.f.s. from #1. (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is Domestic and Irrigation and Operation of (Irrigation, power, mining, manufacturing, domestic supplies, etc.) Hydraulic Ram, being 0.38 c.f.s. for irrigation, 0.01 c.f.s. for ram and 0.01 c.f.s. for domestic.

4. The point of diversion is located #1, 360 South 1609 West #2, 250 ft. South and 1694 ft. West from the NE corner of Abram Olinger D.L.C. No. 57, #3, 1365 South 660 West (Section or subdivision)

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.40 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Three Springs, being 0.10 c.f.s. from North Spring, 0.20 c.f.s. from Middle Spring, and 0.10 c.f.s. from South Spring.

The use to which this water is to be applied is Domestic, Irrigation and Operation of a Ram, being 0.01 c.f.s. for domestic, 0.38 c.f.s. for irrigation and 0.01 c.f.s. for operation of ram.

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is April 22, 1942

Actual construction work shall begin on or before August 10, 1943 and shall thereafter be prosecuted with reasonable diligence and be completed on or before
