* APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, Mrs. Elmina Cole (Name of applicant) of Joseph (Post office), County of Wallowa, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Stanley Creek (Name of stream), a tributary of Wallowa River

2. The amount of water which the applicant intends to apply to beneficial use is 0.15 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is Irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 1920 ft. North and 50 ft. West from the Center of Section 6, (Section or subdivision) (If preferable, give distance and bearing to section corner)

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.14 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Stanley Creek

The use to which this water is to be applied is Irrigation

If for irrigation, this appropriation shall be limited to of one cubic foot per second a diversion of not to exceed 1 acre foot per acre for each acre irrigated during any 30-day period from May 1, to July 31, and thereafter not to exceed 1 acre foot per acre for the remainder of the irrigation season,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is October 5, 1942

Actual construction work shall begin on or before March 5, 1944 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1945

Complete application of the water to the proposed use shall be made on or before October 1, 1946
