* APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, J. P. Harrang (Name of applicant) of Foster (Post office), County of Linn, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Unnamed spring (Name of stream), a tributary of South Santiam

2. The amount of water which the applicant intends to apply to beneficial use is 0.07 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is Domestic supplies and irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 1060 ft. N and 1466 ft. E from the NW corner of NE Quarter Section 26, Township 13 South, Range 1 East, W. M. (Section or subdivision) (If preferable, give distance and bearing to section corner)

5. The Pipe Line (Main ditch, canal or pipe line) to be 1212 Feet (Miles or feet) in length, terminating in the NW 1/4 NE 1/4 of Sec. 26, Tp. 13 S, R. 1 E, W. M., the proposed location being shown throughout on the accompanying map. (Smallest legal subdivision) (N. or S.) (E. or W.)

DESCRIPTION OF WORKS

Diversion Works—

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.01 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Unnamed spring

The use to which this water is to be applied is Domestic

If for irrigation, this appropriation shall be limited to - - - - of one cubic foot per second

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is January 29, 1942

Actual construction work shall begin on or before March 16, 1944 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1945

Complete application of the water to the proposed use shall be made on or before October 1, 1946
