* APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, R. Stadel, (Name of applicant) of Rt. 3 Silverton, (Post office) County of Oregon State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Unnamed stream & Spring (Name of stream) trib. of Brush Crk., a tributary of Pudding River

2. The amount of water which the applicant intends to apply to beneficial use is 0.02 + 0.04 cubic feet per second. being 0.01 c.f.s. for dom, 0.01 c.f.s. for stock & turkeys and 0.04 c.f.s. for ram. (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is Domestic, stock, turkeys and ram, including the irrigation of a garden 1/2 acre in area. (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 4 ft. S and 830 ft. E from the W 1/4 corner of Sec. 10, T. 7 S., R. 1 W., W. M. (Section or subdivision)

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.06 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Unnamed stream and spring, being 0.01 c.f.s. from spring for domestic, stock and turkeys and 0.05 c.f.s. from stream for domestic, turkeys and ram.

The use to which this water is to be applied is Domestic, stock, turkeys, and ram, being 0.01 c.f.s. for domestic, 0.01 c.f.s. for stock and turkeys, and 0.04 c.f.s. for ram, domestic to include irrigation of 1/2 acre of garden. If for irrigation, this appropriation shall be limited to of one cubic foot per second

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is March 17, 1943 for 0.02 c.f.s. and March 20, 1943 for 0.04 c.f.s.

Actual construction work shall begin on or before May 15, 1944 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1945

Complete application of the water to the proposed use shall be made on or before

October 1, 1946
