CERTIFICATE NO. 14751

To appropriate the Public Waters of the State of Oregon

I, Ray Spencer (Name of applicant) of Gold Hill (Post office), County of Jackson, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is spring (Name of stream), a tributary of Rogue River

2. The amount of water which the applicant intends to apply to beneficial use is 0.01 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is domestic (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 490 ft. N and 650 ft. E from the South 1/4 corner of Section 15 (Section or subdivision)

5. The pipe to be 75 feet in length, terminating in the SW 1/4 SE 1/4 of Sec. 15, Tp. 36 S, R. 3 W, W. M., the proposed location being shown throughout on the accompanying map.

DESCRIPTION OF WORKS

Diversion Works—

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.01 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from A Spring

The use to which this water is to be applied is Domestic, including the irrigation of a garden not exceeding 1/2 acre in area,

If for irrigation, this appropriation shall be limited to - - - - - of one cubic foot per second

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is September 3, 1942

Actual construction work shall begin on or before July 23, 1944 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1945

Complete application of the water to the proposed use shall be made on or before October 1, 1946
