To Appropriate the Public Waters of the State of Oregon

I, Emil C. Voss (Name of applicant) of Williams (Post office), County of Josephine, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Glade Fork (Name of stream), a tributary of East Fork Williams Creek

2. The amount of water which the applicant intends to apply to beneficial use is 0.20 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is Irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 600 ft. S and 1100 ft. E from the NW 1/4 corner of Section 14 (Section or subdivision) (If preferable, give distance and bearing to section corner)

5. The Ditch (Main ditch, canal or pipe line) to be 1/2 mile (Miles or feet) in length, terminating in the NE 1/4 NW 1/4 of Sec. 14, Tp. 39 S, R. 5 W, W. M., the proposed location being shown throughout on the accompanying map.

DESCRIPTION OF WORKS

Diversion Works—

6. (a) Height of dam 2 feet, length on top 15 feet, length at bottom 10 feet; material to be used and character of construction Log dam. Plank facing. Rock and earth fill. Wasteway over rock and brush, timber crib, etc., wasteway over or around dam

(c) If water is to be pumped give general description (Size and type of pump) (Size and type of engine or motor to be used, total head water is to be lifted, etc.)

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.20 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Glade Fork, tributary to E. Fork Williams Creek

The use to which this water is to be applied is Irrigation

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 1/2 acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is November 5, 1943

Actual construction work shall begin on or before March 1, 1945 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1946

Complete application of the water to the proposed use shall be made on or before

October 1, 1947
