

* APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, H. O. Douglas (Name of applicant) of Rogue River (Post office), County of Jackson, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Jameson Gulch (Name of stream) Trib. Pleasant Creek, a tributary of Evans Creek

2. The amount of water which the applicant intends to apply to beneficial use is 0.07 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is Irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 500 ft. S. and 400 ft. E. from the W. 1/4 corner of Sec. 10 (Section or subdivision)

DESCRIPTION OF WORKS

Diversion Works—

6. (a) Height of dam 2 feet, length on top 12 feet, length at bottom 10 feet; material to be used and character of construction dirt and rocks (Loose rock, concrete, masonry, waste way over dam. rock and brush, timber crib, etc., wasteway over or around dam)

(b) Description of headgate direct from stream (Timber, concrete, etc., number and size of openings)

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.07 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Jameson Gulch tributary to Pleasant Creek

The use to which this water is to be applied is Irrigation

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 1/2 acre feet per acre for each acre irrigated during the Irrigation season from April 2, to October 31, of each year,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is November 17, 1943

Actual construction work shall begin on or before March 1, 1945 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1946

Complete application of the water to the proposed use shall be made on or before October 1, 1947
