

* APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, J. V. Ayres (Name of applicant) of Gaston Rt. 1 (Post office), County of Oregon, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Tuolatin River (Name of stream), a tributary of Willamette River

2. The amount of water which the applicant intends to apply to beneficial use is 0.32 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

Records of Deeds for Washington County, Oregon said pipe being set at a point S. 2° 30' East 802.56 feet from a rock, the northeast corner of said Baker tract and established in County Survey #1007, said beginning point being the N. W. corner of the J. E. Bates land and the N.E. corner of the Willis Johnston land (1914) and running thence S 2° 30' East 1009.80 ft. to an iron pipe; thence North 80° 25' West 251.50 ft. thence S. 2° 02' West 1156.70 ft. to the center of the Tualatin River, thence following center line of said river S. 37° 14' East 114.39 ft.; thence South 86° 08' E 708 1/2 ft. or to the S. W. corner of a tract of land deeded to R. J. Bates and Rosie J. Bates marked by an iron stake on the North bank of the Tualatin River; thence North 30 chains more or less to an iron stake on the South side of County road marking the N.W. corner of the tract of land deeded to R. PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.32 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Tualatin River

The use to which this water is to be applied is Irrigation

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is April 27, 1945

Actual construction work shall begin on or before June 15, 1946 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1947

Complete application of the water to the proposed use shall be made on or before

October 1, 1948
