

\* APPLICATION FOR PERMIT

To appropriate the Public Waters of the State of Oregon

I, Don H. Wall (Name of applicant) of Rt. 1 Box 143 Salem (Mailing address), State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is unnamed lake and Goose Lake (Name of stream), a tributary of Willamette River

2. The amount of water which the applicant intends to apply to beneficial use is 0.53 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

\*\*3. The use to which the water is to be applied is Irrigation and supplemental irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 40 ft. S and 40 ft. E from the NW corner of NE 1/4 SW 1/4 (Section or subdivision) Diversion point from Goose Lake may be shifted as water recedes or advances

STATE OF OREGON, } ss County of Marion,

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.53 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Unnamed Lake and Goose Lake

The use to which this water is to be applied is Irrigation and Supplemental Irrigation

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year, provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein, and shall be subject to such reasonable rotation system as may be ordered by the proper State Officer.

Water is to be pumped from Unnamed Lake when available to be supplemented by water from Goose Lake in sufficient quantities to make up for any deficiency that may occur in Unnamed Lake and shall be subject to such reasonable rotation system as may be ordered by the proper state officer //

The priority date of this permit is July 9, 1945

Actual construction work shall begin on or before September 1, 1946 and shall thereafter be prosecuted with reasonable diligence and be completed on or before

October 1, 1947 Extended to Oct. 1, 1949 Extended to Oct. 1, 1953

Complete application of the water to the proposed use shall be made on or before
