* APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, Hugh Park and Wayne Park of Summerville, Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation No

1. The source of the proposed appropriation is Spring Creek, a tributary of Willow Creek

2. The amount of water which the applicant intends to apply to beneficial use is 0.75 cubic feet per second.

**3. The use to which the water is to be applied is irrigation

4. The point of diversion is located 2000 ft. South and 2400 ft. East from the N.W. corner of Section 12, Tp. 1 S. R. 38 E. W.M.,

being within the SE 1/4 of Sec. 12, Tp. 1 South R. 38 East, W. M., in the county of Union

5. The pipe line to be about 1500 feet in length, terminating in the NE 1/4 NW 1/4 of Sec. 12, Tp. 1 South R. 38 East, W. M., the proposed location being shown throughout on the accompanying map.

DESCRIPTION OF WORKS

Diversion Works—

6. (a) Height of dam feet, length on top feet, length at bottom feet; material to be used and character of construction

(b) Description of headgate

(c) If water is to be pumped give general description 3-inch CRD American Marsh Pump.

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.75 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Spring Creek

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to 1/40th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated throughout the irrigation season, and shall be still further limited to a diversion of not to exceed 0.75 c.f.s., and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is April 3, 1947

Actual construction work shall begin on or before July 3, 1948 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1949

Complete application of the water to the proposed use shall be made on or before

October 1, 1950
