

* APPLICATION FOR PERMIT

To appropriate the Public Waters of the State of Oregon

I, P. B. Lowd (Name of applicant) of 703 Sherman Street, Medford (Mailing address), State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is spring in gulch (Name of stream), a tributary of Rogue River

2. The amount of water which the applicant intends to apply to beneficial use is .01 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is domestic (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 65 ft. N. and 920 ft. W. from the SE 1/4 corner of Section 2, Township 36 South, Range 3 West (Section or subdivision)

being within the SE 1/4 SW 1/4 of Sec. 2, Tp. 36 S., R. 3 W., W. M., in the county of Jackson

5. The pipe line to be 900 feet in length, terminating in the NE 1/4 NW 1/4 of Sec. 11, Tp. 36 S., R. 3 W., W. M., the proposed location being shown throughout on the accompanying map.

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.01 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from spring in gulch

The use to which this water is to be applied is domestic

If for irrigation, this appropriation shall be limited to - - - of one cubic foot per second

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is June 4, 1947

Actual construction work shall begin on or before July 3, 1948 and shall thereafter be prosecuted with reasonable diligence and be completed on or before

October 1, 1949

Complete application of the water to the proposed use shall be made on or before

October 1, 1950
