* APPLICATION FOR PERMIT

To appropriate the Public Waters of the State of Oregon

I, Thos. J. Radcliffe (Name of applicant) of McMinnville, Rt. 1, Box 133 (Mailing address), State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is South Yamhill River (Name of stream), a tributary of Yamhill R.

2. The amount of water which the applicant intends to apply to beneficial use is 0.50 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 1600 ft. N and 1670 ft. E from the SW corner of (Section or subdivision)

Beginning at an iron pipe and stake set 1227.96/18.96 chains) south of the Northwest corner of the Isalah M. Johns Donation Land Claim Notification No. 1238, Claim No. 81, Township 4 South, Range 7 West of the Willamette Meridian, in Yamhill County, Oregon, from which said iron pipe and stake a fir 12 inches in diameter marked "C" in County Survey No. 121 bears North 46° East 61 links distant, and running thence North 89° 25' West 664.33 feet to the center of Yamhill River, thence up the center of said River as follows: South 12° East 100 feet, South 37° 57' East 219.90 feet, South 27° 31' East 600.90 feet, South 25° 25' East 792.10 feet to the Northwest corner of a 3.39 acre tract of land conveyed by Henry Lee Fletcher and wife to the City of McMinnville, Oregon, by deed recorded at page 412 of Volume 94 of the Records of Deeds for Yamhill County, Oregon, thence East 355 feet to the Northeast corner of said 3.39 acre tract, thence along the East line of said 3.39 acre tract as follows: South 31° 30' East 170 feet, South 16° 6' East 174 feet, South 174 feet to the Southeast corner of said 3.39 acre tract, thence West 16 feet, thence South 9' West 1031.50 feet to an iron pipe set in the center of the County Road, thence East 565.23 feet to the Southwest corner of an 80 acre tract conveyed by Henry Lee Fletcher and wife to Victor C. Delasmutt by deed recorded at page 193 of Vol. 102 of the Records of Deeds for Yamhill County, Oregon, thence North 3008.1 feet along the West line of said Delasmutt 80-acre tract to the Northwest corner thereof, and thence South 89° 25' West 1175.81 feet to the place of beginning. Subject to the right of way 16 feet wide as described in said Deed from Henry Lee Fletcher and wife to the City of McMinnville, Oregon, hereinabove described. Also subject to rights of way for public roads as same now exist over and across said property.

STATE OF OREGON, } ss County of Marion,

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.50 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from South Yamhill River

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is August 30, 1948

Actual construction work shall begin on or before January 17, 1950 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1950

Complete application of the water to the proposed use shall be made on or before October 1, 1951
