APPLICATION FOR A PERMIT

To Appropriate the Public Waters of the State of Oregon

I, Town of Mitchell (Name of Applicant)

State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

1. The source of the proposed appropriation is Mill Creek, (Name of stream) Bridge Cr. & John Day river, tributary of

2. The amount of water which the applicant intends to apply to beneficial use is 1 cubic feet per second.

3. The use to which the water is to be applied is Municipal purposes (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located South 13.11 chains from headgate of Taylor (Give distance and bearing to section corner) and Sheppard West Ditch, following course of pipe line

being within the SE 1/4 of SE 1/4 of Sec. 13, Tp. 12 S, R. 21 E, Wheeler (Give smallest legal subdivision) (No. N. or S.) (No. E. or W.)

5. The pipe line to be 3 & 1/8 miles in length, terminating in the NW 1/4 of NE 1/4 of Sec. 1, Tp. 12 S, R. 21 E (Main ditch, canal or pipe line) (Smallest legal subdivision) (No. N. or S.) (No. E. or W.) W. M., the proposed location being shown throughout on the accompanying map.

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eighth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper State officer.

This appropriation shall be limited to municipal supply

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed one (1.0) cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is May 23, 1914.

Actual construction work shall begin on or before Aug 13, 1915

and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1916

Complete application of the water to the proposed use shall be made on or before

Oct 1, 1917
