

APPLICATION FOR PERMIT

To appropriate the Public Waters of the State of Oregon

I, Clifford A. Larkin of Rt. 1 Menzies, Oregon State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation.

1. The source of the proposed appropriation is Oliver Creek a tributary of Muddy Creek

2. The amount of water which the applicant intends to apply to beneficial use is 192 cubic feet per second.

3. The use to which the water is to be applied is Irrigation

4. The point of diversion is located 191 ft. 3 in SSE and 157 ft. E from the NE corner of the property of Widana Scripley as described in Book 51, page 30 at Benton County Deed Records. Being 3200 ft. N. & 1950 ft. W. of the SW cor. of the John Loose D.C. No. 53

being within the NE 1/4, NE 1/4, SE 1/4 of Sec. 13 Tp. 14 S R. 6 W. W. M. in the county of Benton
