This is to certify that I have examined the foregoing application and do hereby grant the same
SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use
and shall not exceed 0.015 cubic feet per second measured at the point of diversion from the
stream, or its equivalent in case of rotation with other water users, from a spring

The use to which this water is to be applied is domestic and stock.

If for irrigation, this appropriation shall be limited to of one cfs per
second

It shall be subject to such reasonable rotation system as may be ordered by the proper state officer

The priority date of this permit is December 12, 1949

Actual construction work shall begin on or before November 20, 1950 and shall
be prosecuted with reasonable diligence and be completed on or before October 1, 1951

The date of expiration of the permit shall be made on or before October 1, 1951
