

\*APPLICATION FOR PERMIT

To appropriate the Public Waters of the State of Oregon

I, G. R. Palmer (Name of applicant)

of Route 1, Box 347 Gold Hill (Mailing address)

State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Middle Fork Foots Creek, a tributary of Foots Creek, a tributary of Rogue River

2. The amount of water which the applicant intends to apply to beneficial use is 0.19 c.f.s. cubic feet per second.

\*\*3. The use to which the water is to be applied is Irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc)

4. The point of diversion is located 59 ft. N. and 169 ft. W. from the S 1/4 corner of Section 13, being within the SE 1/4 SW 1/4 of Section 13, Township 37 South, Range 4 West. #2 Diversion is located 1210 feet North and 250 feet West from the S 1/4 corner of Section 13,

being within the SE 1/4 SW 1/4 of Sec. 13 Tp. 37S R. 4W W. M., in the county of Jackson

5. The main ditch and pipe line to be 2000 feet (approximately) in length, terminating in the SE 1/4 SW 1/4 of Sec. 13 Tp. 37S R. 4W W. M., the proposed location being shown throughout on the accompanying map.

DESCRIPTION OF WORKS

Diversion Works--

6. (a) Height of dam 2.0 feet, length on top 20 feet, length on bottom 10 feet; material to be used and character of construction loose rock and dirt.

To facilitate pumping only (both diversion points) rock and brush, timber crib, etc., wasteway over or around dam

(b) Description of headgate none (Timber, concrete, etc., number and size of openings)

(c) If water is to be pumped give general description 3.0 inch centrifugal pump powered by 115 H.P. gasoline engine - total lift 90 feet (Size and type of engine or motor to be used, total head water to be lifted)

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.19 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Middle Fork Foots Creek

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to 1/80 of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer

The priority date of this permit is June 15, 1955

Actual construction work shall begin on or before November 21, 1956 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1957

Complete application of the water to the proposed use shall be made on or before October 1, 1958
