

*APPLICATION FOR PERMIT

To appropriate the Public Waters of the State of Oregon

I, CLARENCE V. HODGES (Name of applicant) of R.T. 1, Box 175 - WEST LINN (Mailing address) State of OREGON, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Unnamed Stream and Reservoir (Name of stream), a tributary of Tualatin River

2. The amount of water which the applicant intends to apply to beneficial use is 0.21 cubic feet per second. Stock Water: 0.20 / Domestic Supplies: 0.01 (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is Stock Water & Domestic Supplies (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.02 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from unnamed stream and reservoir to be constructed under Application No. R-31942, Permit No. R-2087.

The use to which this water is to be applied is domestic use for one family, and stock, being 0.01 c.f.s. for each

If for irrigation, this appropriation shall be limited to of one cubic foot per second or its equivalent for each acre irrigated

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is October 16, 1957

Actual construction work shall begin on or before November 29, 1958 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1959

Complete application of the water to the proposed use shall be made on or before October 1, 1960
