

APPLICATION FOR PERMIT

To appropriate the Public Waters of the State of Oregon

I, Natron Plywood Co. (Name of applicant)

State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation Incorporated in Oregon under name of Natron Kilns June 18, 1951. Name changed to Natron Plywood Co. Jan. 3, 1956

1. The source of the proposed appropriation is Unnamed Stream in old bed of Middle Fork of the Willamette River, a tributary of Willamette River

2. The amount of water which the applicant intends to apply to beneficial use is Irrig. - 0.70 cubic feet per second. Plant - 0.34
Total 1.04

**3. The use to which the water is to be applied is Plywood Manufacturing and Irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 900 ft. S. and 50 ft. W. from the Corner of the John C. Looney corner of Sec. 10, T. 2N, R. 2W (Section or subdivision)

DESCRIPTION OF WORKS

Diversion Works—

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.13 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from unnamed stream

The use to which this water is to be applied is irrigation and manufacturing, being 0.79 c.f.s. for irrigation and 0.34 c.f.s. for manufacturing.

If for irrigation, this appropriation shall be limited to 1/80 of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is April 9, 1958

Actual construction work shall begin on or before May 26, 1959 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1960

Complete application of the water to the proposed use shall be made on or before October 1, 1961
