APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, Herman M Farmer (Name of Applicant)

of Beaver (Postoffice), County of Tillamook

State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Unnamed (Name of stream), tributary of Big Nestucca River

2. The amount of water which the applicant intends to apply to beneficial use is entire flow of creek about 1 1/2 cubic feet per second.

3. The use to which the water is to be applied is Irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located South 20° 7' East 430 feet from the NW corner of NE 1/4 of NE 1/4 of Sec. 1 T 4 S R 10 W (Give distance and bearing to section corner)

being within the NE 1/4 of NE 1/4 of Sec. 1, Tp. 4 S, R. 10 W, W. M., in the county of Tillamook, Oregon (No. E. or W.)

5. The main ditch to be 750 feet miles in length, terminating in the NE 1/4 of NE 1/4 of Sec. 1, Tp. 4 S, R. 10 W (Smallest legal subdivision) (No. N. or S.) (No. E. or W.) W. M., the proposed location being shown throughout on the accompanying map.

6. The name of the ditch, canal or other works is Farmer's Irrigation Ditch

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper State officer.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 0.12 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is September 2, 1915

Actual construction work shall begin on or before September 9, 1916 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1917

Complete application of the water to the proposed use shall be made on or before October 1, 1918
