APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, D H Norton (Name of Applicant)

of Almeda (Postoffice), County of Josephine

State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Wildcat Creek and Unnamed Creek (Name of stream) about 3000 feet SW of Wildcat Creek is tributary of Rogue River

2. The amount of water which the applicant intends to apply to beneficial use is about thirty cubic feet per second.

3. The use to which the water is to be applied is Hydraulic Mining (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 2000 feet from mouth of Wildcat Creek and 1200 feet from mouth of unnamed creek in Siskiyou National Forest (Give distance and bearing to section corner)

being within the SE SW 32 33 S SW NW 5 34 S (Give smallest legal subdivision) of Sec. 5, Tp. (No. N. or S.)

R. 8 W W. M., in the county of Josephine (No. E. or W.)

5. The main ditch to be about one miles in length, terminating in the SW SW 32 33 S R. 8 W (Smallest legal subdivision) (No. N. or S.) (No. E. or W.)

W. M., the proposed location being shown throughout on the accompanying map.

6. The name of the ditch, canal or other works is Lookout Point Placer Ditch

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper State officer.

The use of the water under this permit shall be limited to water for hydraulic mining

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 30.0 cubic feet per second, or its equivalent in case of rotation.

The priority date of this permit is November 1, 1915

Actual construction work shall begin on or before November 13, 1916

and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1917

Complete application of the water to the proposed use shall be made on or before October 1, 1918
