APPLICATION FOR PERMIT

To appropriate the Public Waters of the State of Oregon

I, R. H. Pools (Name of applicant)

of Route 4, Box 458, Grants Pass, (Mailing address)

State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Applegate River (Name of stream), a tributary of Rogue River

2. The amount of water which the applicant intends to apply to beneficial use is 0.25 c.f.s.a. cubic feet per second. (If water is to be used from more than one source, give quantity from each)

\*3. The use to which the water is to be applied is irrigation. (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 1050 ft. S. and 500 ft. E. from the NE corner of Section 25 (N. or S.) (E. or W.) (Section or subdivision)

being within the NE 1/4 NW 1/4 of Sec. 25, Tp. 30 S. (Give smallest legal subdivision) (N. or S.)

DESCRIPTION OF WORKS

Diversion Works—

6. (a) Height of dam feet, length on top feet, length at bottom feet; material to be used and character of construction NEW BERRYMAN DITCH diversion. (Loose rock, concrete masonry, rock and brush, timber crib, etc., wasteway over or around dam)

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.25 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Applegate River

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to 1/80<sup>th</sup> of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4/2 acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to use of water shall be limited to the period when the flow in the Rogue River is more than 735 c.f.s. at its mouth,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is February 24, 1961

Actual construction work shall begin on or before April 13, 1962 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1962

Complete application of the water to the proposed use shall be made on or before October 1, 1963
