

APPLICATION FOR PERMIT

To Appropriate the Public Waters of the State of Oregon

I, VERE C MORRELL (Name of applicant) of Rte 1 Box 748 Cottage Grove (Mailing address) State of OREGON, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is GIDDINGS CREEK and N.E. Fork of Giddings Cr. Fork, a tributary of WILLAMETTE RIVER (Name of stream)

2. The amount of water which the applicant intends to apply to beneficial use is .80 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is IRRIGATION (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 825 ft. N. and 252 ft. W from the corner of N.E. COR. 25 VANDERVEER D.L.C. NO. 49 and 135 1/2 N AND 270 E 1/4 NE COR. of D.L.C. #44 IN SECTION 11 AND 14 T14S R1E S.P. 3rd. WILLAMETTE MERIDIAN Giddings Cr. - 1135' N and 2240' W from NE COR. D.L.C. No. 49 (Section or subdivision) (If preferable, give distance and bearing to section corner)

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.80 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Giddings Creek and North Fork Giddings Creek, being 0.60 c.f.s. from Giddings Creek and 0.20 c.f.s. from North Fork Giddings Creek

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to 1/80 of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is June 6, 1961

Actual construction work shall begin on or before August 11, 1962 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1963.

Complete application of the water to the proposed use shall be made on or before October 1, 1964
