APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, Otho C Spragg (Name of Applicant)

of Freewater, County of Umatilla (Postoffice)

State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is L. Walla Walla River (Name of stream)

tributary of Walla Walla

2. The amount of water which the applicant intends to apply to beneficial use is 0.25 cubic feet per second.

3. The use to which the water is to be applied is Irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located approx. 290 ft. West and 40 ft. South of the centre of SE 1/4 Sec. 35 and also waste water from the North 1/2 SW 1/4 of said Section 35 (Give distance and bearing to section corner)

being within the SW of SE of Sec. 35, Tp. 6 N (Give smallest legal subdivision) (No. N. or S.)

R. 35 E, W. M., in the county of Umatilla (No. E. or W.)

5. The ditch to be about 1/2 miles in length, terminating in the SE 1/2 NW 1/4 SW 1/4 of Sec. 35, Tp. 6 N, R. 35 E (Smallest legal subdivision) (No. N. or S.) (No. E. or W.)

W. M., the proposed location being shown throughout on the accompanying map.

STATE OF OREGON, County of Marion ss.

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper State officer.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 0.25 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is December 24, 1915

Actual construction work shall begin on or before January 4, 1917

and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1918

Complete application of the water to the proposed use shall be made on or before October 1, 1919
