

APPLICATION FOR PERMIT

To appropriate the Public Waters of the State of Oregon

I, John and Mary P. Rinaldi (Name of applicant)

State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Unnamed spring and stream from spring, a tributary of Hubbard Creek

2. The amount of water which the applicant intends to apply to beneficial use is 0.02 cubic feet per second. 0.01 from spring for Domestic and 0.01 from stream for fish & recreation in pond.

3. The use to which the water is to be applied is Domestic fish and recreations

4. The point of diversion is located 1832 ft. S and 2720 ft. E from the Sec. corner of Sections 16, 17, 20, and 21

being within the S.E. 1/4 N.W. 1/4 of Sec. 21, Tp. 25 S., R. 7 W., W. M., in the county of Douglas

5. The Pipe line to be 350 ft. in length, terminating in the SE 1/4 NW 1/4 of Sec. 21, Tp. 25 S., R. 7 W., W. M., the proposed location being shown throughout on the accompanying map.

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.02 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from unnamed spring and unnamed stream, being 0.01 c.f.s. from unnamed spring for domestic use and 0.01 c.f.s. from unnamed stream for maintenance of reservoir.

The use to which this water is to be applied is domestic use of one family and maintenance of a reservoir to be constructed under application No. R-37523, permit No. R-2961 for fish culture and recreation within the reservoir, provided further that the right to use of water for fish culture and recreation within the reservoir is limited to the period when the flow of the Umpqua River at tidewater is more than 525 c.f.s.

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is April 4, 1962

Actual construction work shall begin on or before July 26, 1963 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1964

Complete application of the water to the proposed use shall be made on or before October 1, 1965
