

APPLICATION FOR PERMIT

To appropriate the Public Waters of the State of Oregon

I, Joe W Crowe (Name of applicant) of Route 1 Box 12 Sheridan (Mailing address) State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use 6.0 acre feet stored water only and shall not exceed \_\_\_\_\_ cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Crows Reservoir No. 1 to be constructed under application No. R-39626, permit No. R-3954.

The use to which this water is to be applied is irrigation

a diversion of 2 1/2 acre feet

If for irrigation, this appropriation shall be limited to \_\_\_\_\_ of \_\_\_\_\_ cubic feet per second on \_\_\_\_\_ for each acre irrigated during the irrigation season of each year.
