

APPLICATION FOR PERMIT

To appropriate the Public Waters of the State of Oregon

I, Richard C. Synowski, of Polk Co., Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Eagle Crest Reservoir, a tributary of Gibson Gulch

2. The amount of water which the applicant intends to apply to beneficial use is 0.03 cubic feet per second.

3. The use to which the water is to be applied is Fish Culture

4. The point of diversion is located 35 ft. N and 54.5 ft. E from the E 1/2 corner of Sec. 11, T7S, R4W

being within the SE 1/4 of the NE 1/4 of Sec. 11, Tp. 7S, R. 4W, W. M., in the county of Polk

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.03 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from an unnamed stream and Eagle Crest Reservoir to be constructed under application No. R-40444, permit No. R-4549

The use to which this water is to be applied is fish culture

If for irrigation, this appropriation shall be limited to of one cubic foot per second or its equivalent for each acre irrigated

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is December 1, 1964

Actual construction work shall begin on or before May 20, 1966 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1967

Complete application of the water to the proposed use shall be made on or before October 1, 1968
