APPLICATION FOR PERMIT

To appropriate the Public Waters of the State of Oregon

I, Linn County (Linn County Court) of Court House Albany, Oregon State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Oak Creek, a tributary of Calapooia River

2. The amount of water which the applicant intends to apply to beneficial use is 4.04 cubic feet per second, being 4.0 c.f.s. for maintaining reservoirs for res. & 0.04 c.f.s. for irrigation.

3. The use to which the water is to be applied is irrigation & maintaining 3 reservoirs for public recreation & irrigation.

4. The point of diversion is located 150 ft. S. and 400 ft. W. from the NE corner of Sec. 28, & 300 feet south and 400 feet west from the NE corner of Sec. 28, T. 11 S., R. 3 W., N.M. Maintaining reservoirs 5 feet south and 630 east from the NW corner of Section 28, T. 11 S., R. 3 W., N.M.

being within the NE 1/4, NW 1/4 & NW 1/4 of Sec. 28, Tp. 11 S. R. 3 W., W. M., in the county of

Remarks: _____ Linn County wishes to file for all unappropriated
water now flowing in Oak Creek during the months of April, May, June,
July, August, and September. These waters will be used primarily
for recreational purposes, or minor miscellaneous usage in connection
with recreational purposes. In 1958-59 an area of 56.2 acres was
obtained by the State of Oregon with a barrow pit being developed,
the pit being filled by water from Oak Creek. These lakes have been
formed, totaling 37.9 acres of water with an average depth of
approximately five feet. The lakes are located in the N.W. $\frac{1}{4}$ of

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 4.04 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Oak Creek and reservoir to be constructed under Application No. R-40901, Permit No. R-4569

The use to which this water is to be applied is Irrigation and recreation; being 0.04 c.f.s. for irrigation and 4.00 c.f.s. for recreation.

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated, from direct flow and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir to be constructed under permit No. R-4569

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is November 12, 1964

Actual construction work shall begin on or before June 25, 1966 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1967

Complete application of the water to the proposed use shall be made on or before October 1, 1968
