To Appropriate the Public Waters of the State of Oregon

I, Walter A. Woodard (Name of applicant)

State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Coast Fork of Willamette River (Name of stream) and Currin Creek, a tributary of Willamette River

2. The amount of water which the applicant intends to apply to beneficial use is 1/80 cu. ft. cubic feet per second. PER ACRE for irrigation & 0.02 from creek to maintain reservoir. (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is Irrigation and maintaining reservoir for bird sanctuary. (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 1900 ft. S and 920 ft. W from the NE corner of Section 5, Township 21 South, Range 3 West, W.M. in Lane County, Oregon (Section or subdivision)

Currin Creek-- 1370 feet South and 300 feet West from the NE corner of Section 5, T. 21 S., R. 3 W., W.M. (If preferable, give distance and bearing to section corner)

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.08 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Coast Fork Willamette River and Currin Creek and reservoir to be constructed under Application No. R-40814 Permit No. R-4572

The use to which this water is to be applied is irrigation and bird sanctuary; being 0.06 c.f.s., from Coast Fork Willamette River for irrigation and 0.02 c.f.s., from Currin Creek and reservoir for bird sanctuary.

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year,

The right allowed herein for bird sanctuary shall be subordinate and inferior to all future rights for beneficial consumptive uses,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is April 29, 1965

Actual construction work shall begin on or before June 25, 1966 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1967

Complete application of the water to the proposed use shall be made on or before October 1, 1968
