STATE ENGINEER APPLICATION FOR PERMIT

CERTIFICATE NO. 39776

To appropriate the Public Waters of the State of Oregon

I, WENDELL M. FALES (Name of applicant) of Rt. 1, Box 787, CAVE Junction, OREGON, (Mailing address) State of OREGON, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is PARKER CREEK (Name of stream), a tributary of Rough and Ready Creek

2. The amount of water which the applicant intends to apply to beneficial use is 1.090 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

\*\*3. The use to which the water is to be applied is IRRIGATION (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 225 ft. N and 175 ft. W from the 1/4 corner of Sec. 12 and Sec. 13 T40S R. 9W.W.M. (Section or subdivision)

being within the S.E. 1/4 of S.W. 1/4 of Sec. 12, Tp. 40S, R. 9W., W. M., in the county of JOSEPHINE (Give smallest legal subdivision) (N. or S.)

DESCRIPTION OF WORKS

Diversion Works—

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.09 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Parker Creek

The use to which this water is to be applied is irrigation and supplemental irrigation

If for irrigation, this appropriation shall be limited to 1/50th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is June 16, 1965

Actual construction work shall begin on or before October 22, 1966 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1967.

Complete application of the water to the proposed use shall be made on or before October 1, 1968.
