APPLICATION FOR A PERMIT

To Appropriate the Public Waters of the State of Oregon

I, J O Pierce (Name of Applicant)

of Gold Hill, County of Jackson (Postoffice)

State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation.

1. The source of the proposed appropriation is Galls Creek (Name of stream), tributary of Rogue River

2. The amount of water which the applicant intends to apply to beneficial use is one-tenth cubic feet per second.

3. The use to which the water is to be applied is Irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located Eighty rods East & ten rods North of the Southwest corner of Section 28 (Give distance and bearing to section corner)

being within the SW 1/4 of SW 1/4 of Sec. 28, Tp. 36 S (Give smallest legal subdivision) (No. N. or S.)

R. 3 W, W. M., in the county of Jackson (No. E. or W.)

5. The extension to be 50 rods miles in length, terminating in the SW 1/4 of NW 1/4 of Sec. 28, Tp. 36 S, R. 3 W (Main ditch, canal or pipe line) (Smallest legal subdivision) (No. N. or S.) (No. E. or W.)

W. M., the proposed location being shown throughout on the accompanying map.

6. The name of the ditch, canal or other works is The Cook Ditch extension

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper State officer.

The use of the water under this permit shall be limited to water for irrigation purposes.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 0.08 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is August 10, 1916

Actual construction work shall begin on or before August 21, 1917 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1918

Complete application of the water to the proposed use shall be made on or before October 1, 1919
