## APPLICATION FOR A PERMIT

## To appropriate the Public Waters of the State of Oregon

I, J J Hauri and John Lauerman

(Name of Applicant)

of Central Point, County of Jackson

State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Lower Bear Creek Drainage Slough

2. The amount of water which the applicant intends to apply to beneficial use is  
 two (2) cubic feet per second.

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eighth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper State officer.

The use of the water under this permit shall be limited to water for a supplemental supply for the irrigation of land already having a partial water right under Application No. 2849, Permit No. 1502.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 1.0 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is July 26, 1916

Actual construction work shall begin on or before August 28, 1917 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1918

Complete application of the water to the proposed use shall be made on or before October 1, 1919
