APPLICATION FOR A PERMIT

To Appropriate the Public Waters of the State of Oregon

I, Mrs. R. P. Miller (Name of Applicant)

State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Wet weather lake springs & storm water and the water stored in the Mrs R. P. Miller Reservoir to be constructed under application No 5143, Permit No R 375, tributary of Crooked River Watershed

2. The amount of water which the applicant intends to apply to beneficial use is 1.25 cubic feet per second.

3. The use to which the water is to be applied is Irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located north 530 ft to corner between Section 22 & 23, T. 17 S., R. 20 E., W.M.

being within the NE 1/4 of SE 1/4 of Sec. 22, Tp. 17 S.

R. 20 E., W. M., in the county of Crook

5. The Ditches to be one miles in length, terminating in the SW 1/4 of NE 1/4 of Sec. 22, Tp. 17 S., R. 20 E.

W. M., the proposed location being shown throughout on the accompanying map.

6. The name of the ditch, canal or other works is Mrs. R. P. Miller Reservoir & Ditches

DIVERSION WORKS—

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eighth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper State officer.

The use of the water under this permit shall be limited to water for irrigation purposes from Wet Weather Springs and storm water and the water stored in the Mrs. R.P. Miller Reservoir to be constructed under application No. 5143, permit No. R-375

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 1.25 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is September 6, 1916

Actual construction work shall begin on or before October 4, 1917 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1918.

Complete application of the water to the proposed use shall be made on or before October 1, 1919
