To appropriate the Public Waters of the State of Oregon

following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed .....0.53..... cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from ..... Abiqua Creek

The use to which this water is to be applied is ..... irrigation
