

*APPLICATION FOR PERMIT

To appropriate the Public Waters of the State of Oregon

I, Herbert Spady (Name of applicant) of 9460 Sunnyview NE Salem (Mailing address) State of Oregon, do hereby make application for a permit to appropriate the

following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

1. The source of the proposed appropriation is Pudding River and Spady Reservoir (Name of stream), a tributary of Molalla River

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed0.17..... cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from ~~0.17 cfs from~~ Pudding River; for primary irrigation and 25.0 af from reservoir to be constructed under application No. R-41650, Permit No. R-4717 for supplemental irrigation.....

The use to which this water is to be applied isirrigation and supplemental irrigation.....

If for irrigation, this appropriation shall be limited to1/80th..... of one cubic foot per second or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir to be constructed under Permit No. R-4717 and ~~permitted~~ to the use of stored water only on the lands described as supplemental.....

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.
