This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.05 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from unnamed stream, Deer Creek and reservoir to be constructed under application No. R-42692, Permit No. R-4729

water to be appropriated from unnamed stream and reservoir and any deficiency in the unnamed stream to be made up by appropriation from Deer Creek providing the total quantity ~~The use to which this water is to be applied is fish culture~~ to be appropriated shall not exceed 0.05 cfs
