# To appropriate the Public Waters of the State of Oregon

State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, **SUBJECT TO EXISTING RIGHTS:**

## DESCRIPTION OF WORKS

### Diversion Works—

6. (a) Height of dam Four feet, length on top twenty feet, length at bottom twenty feet; material to be used and character of construction Concrete  
(Loose rock, concrete, masonry, rock and brush, timber crib, etc., wasteway over or around dam)

(b) Description of headgate Timber 4 ft. high, 6 ft. wide  
(Timber, concrete, etc., number and size of openings)

(c) If water is to be pumped give general description Electrical Driven Pump  
(Size and type of pump)  
capable of delivering 150 GPM @ 75# PSI, 5' head  
(Size and type of engine or motor to be used, total head water is to be lifted, etc.)

\*\*Application for permits to appropriate water for the generation of electricity, with the exception of municipalities, must be made to the Hydroelectric Commission. Either of the above forms may be secured, without cost, together with instructions by addressing the State Engineer, Salem, Oregon.

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.25 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Allen Creek

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is March 29, 1966

Actual construction work shall begin on or before January 18, 1968 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1968

Complete application of the water to the proposed use shall be made on or before October 1, 1969
