

*APPLICATION FOR PERMIT

To appropriate the Public Waters of the State of Oregon

I, J. Eugene Scott (Name of applicant) of Rt. 1 Box 88 Cove (Mailing address), State of Ore, do hereby make application for a permit to appropriate the

following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Mill Cr. (Name of stream), a tributary of Grande Ronde

2. The amount of water which the applicant intends to apply to beneficial use is 2.30 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed2.30..... cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Mill Creek.....

The use to which this water is to be applied isirrigation and supplemental irrigation.....

If for irrigation, this appropriation shall be limited to1/80th..... of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation..... season of each year, provided further that the right allowed herein shall be..... limited to any deficiency in the available supply of any prior right existing for..... the same land and shall not exceed the limitation allowed herein and the appropriation of water for the lands described as supplemental shall be limited to the period..... between September 1 and April 30 of each year,.....

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.
