I, Wm E. Beyer (Name of applicant) of 47 Eastfield Dr. (Mailing address) Rolling Hills State of Calif. 90274, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

1. The source of the proposed appropriation is Spring, 2 Unnamed Streams & 2 Reservoirs, a tributary of N. Santiam River (Name of stream)

2. The amount of water which the applicant intends to apply to beneficial use is cubic feet per second. W. Stream 0.01 cfs, Unn. Str. & Res No. 1 0.03 cfs, Unn. Str. and Res. No. 2 0.06 cfs (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is Dam 0.01 from W. Stream & Irrigation 0.09 cfs from 2 Unn. Streams & 2 Reservoirs (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 1290 ft. N. and 250 ft. W from the SE 1/4 corner of Sec 32 Spring Stream (Section or subdivision)

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.10 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from two unnamed streams and two reservoirs to be constructed under application No. R-43963, permit No. R-5058

The use to which this water is to be applied is domestic use of one family and irrigation being 0.01 cfs for domestic from west stream, 0.03 cfs from west stream and reservoir and 0.06 cfs from east stream and reservoir for irrigation

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoirs to be constructed under permit No. R-5058

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is August 16, 1967

Actual construction work shall begin on or before March 18, 1969 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1969...

Complete application of the water to the proposed use shall be made on or before October 1, 1970...
