*APPLICATION FOR PERMIT

To appropriate the Public Waters of the State of Oregon

I, Elenore Peck Phillips (Name of applicant)

of 1076 E. Wiley Creek Road, Sweet Home (Mailing address)

State of OREGON, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Wiley Creek (Name of stream)

, a tributary of So. Santiam

2. The amount of water which the applicant intends to apply to beneficial use is 0.12125 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

4. The point of diversion is located N. 8° W. 1250 feet ft. and ft. from the SE corner of NE 1/4 of S. 34 (Section or subdivision)

DESCRIPTION OF WORKS

Diversion Works—

6. (a) Height of dam feet, length on top feet, length at bottom feet; material to be used and character of construction (Loose rock, concrete, masonry, rock and brush, timber crib, etc., wasteway over or around dam)

Either of the above forms may be secured, without cost, together with instructions by addressing the State Engineer, Salem, Oregon.

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.12 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Wiley Creek

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is May 16, 1968

Actual construction work shall begin on or before January 20, 1970 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1970...

Complete application of the water to the proposed use shall be made on or before October 1, 1971...
