following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use 2.5 acre feet stored water only and shall not exceed ~~subject per acre~~ measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from McCrae Reservoir to be constructed under application No. R-45091, permit No. R-5325

The use to which this water is to be applied is irrigation and stock being 2.0 af for irrigation and 0.5 af for stock

If for irrigation, this appropriation shall be limited to ~~subject per acre~~ a diversion of 2 1/2 acre feet for each acre irrigated during the irrigation season of each year.

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is June 21, 1968

Actual construction work shall begin on or before February 24, 1970 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1970.

Complete application of the water to the proposed use shall be made on or before October 1, 1971.
