

\*APPLICATION FOR PERMIT

To appropriate the Public Waters of the State of Oregon

I, Clarence Gaffin (Name of applicant) of Pt. 1 Box 451 Aumsville (Mailing address) State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Unnamed Creek and Springs Reservoir (Name of stream), a tributary of Beaver Creek

2. The amount of water which the applicant intends to apply to beneficial use is 5.7 Ac. Ft. cubic feet per second. (If water is to be used from more than one source, give quantity from each)

\*\*3. The use to which the water is to be applied is Irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 850 ft. N and 525 ft. W from the SE 1/4 corner of Property Sec 8 (Section or subdivision)

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use 5.7 acre feet stored water only and shall not exceed ~~..... cubic feet per second~~ measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from reservoir to be constructed under application No. R-45206, permit No. R-5333

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to ~~..... of one cubic foot per second or its equivalent for each acre irrigated~~ a diversion of 2 1/2 acre feet for each acre irrigated during the irrigation season of each year

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is July 31, 1968

Actual construction work shall begin on or before March 11, 1970 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1970

Complete application of the water to the proposed use shall be made on or before October 1, 1971
