

\*APPLICATION FOR PERMIT

To appropriate the Public Waters of the State of Oregon

I, Ronald E. Strand (Name of applicant) of 9230 Alaska St. SE, Salem (Mailing address) State of Oregon, do hereby make application for a permit to appropriate the

following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Little Pudding River (Name of stream) a tributary of Pudding River

2. The amount of water which the applicant intends to apply to beneficial use is 0.18 cubic feet per second.

\*\*3. The use to which the water is to be applied is Recreation & Irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.) being 0.02 cfs rec. & 0.16 cfs irrig. (River only)

4. The point of diversion is located N. 52° 45' W 685 ft. (N. or S.) and ft. (E. or W.) from the NW corner of W. Taylor D.C. No. 66 (Section or subdivision)

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed .....0.18..... cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Little Pudding River and reservoir to be constructed under application No. R-46294, permit No. R-5507.....

The use to which this water is to be applied is for recreation and irrigation, being 0.02 cfs for recreation from Little Pudding River and reservoir and 0.16 cfs for irrigation from river.

If for irrigation, this appropriation shall be limited to .....1/80..... of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is .....August 8, 1969.....

Actual construction work shall begin on or before .....April 24, 1971..... and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1972..
