To Appropriate the Public Waters of the State of Oregon

I, Reed Neuschwanger (Name of applicant) of Rt 1 Box 104 Sheridan (Mailing address) State of Oregon 97378, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

1. The source of the proposed appropriation is Neuschwanger Reservoir (Name of stream), a tributary of Yamhill River

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use acre feet stored water only and shall not exceed 1.9 acre feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from reservoir to be constructed under application No. R-46307, permit No. R-5511.

The use to which this water is to be applied is irrigation and stock, being 0.5 af for irrigation and 1.4 af for stock.

If for irrigation, this appropriation shall be limited to ~~one acre foot per second or the equivalent for each acre irrigated~~ a diversion of 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is August 12, 1969.

Actual construction work shall begin on or before April 24, 1971 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1972.

Complete application of the water to the proposed use shall be made on or before October 1, 1973.
